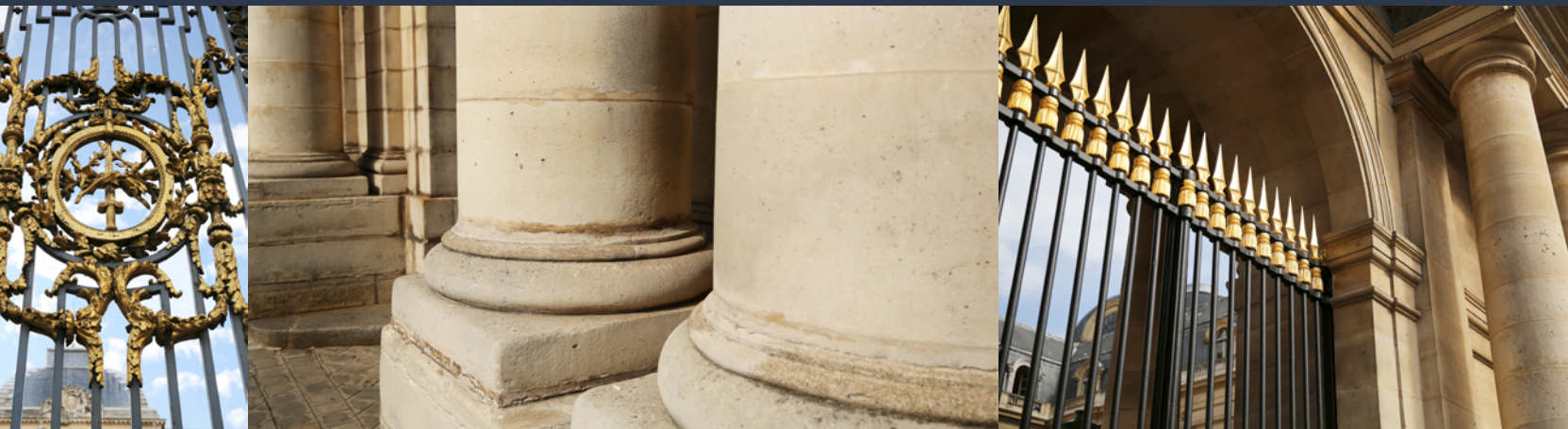

## Practices



### **Attorney to the Supreme Courts of France (*Conseil d'État* and *Cour de cassation*)**

The primary purpose of Cabinet Briard is to represent litigants in the final stage of a trial, i.e. judicial review, before the French Supreme Courts (*Conseil d'État* and *Cour de cassation*).

### **Attorney before the Constitutional Council (*Conseil constitutionnel*)**

Cabinet Briard addresses the Constitutional Council when it examines statutes prior to (external contributions) as well as subsequent to their enactment (preliminary rulings). It also assists candidates defeated at the legislative elections and seeking to challenge election results.

### **Attorney before Administrative Jurisdictions**

Cabinet Briard assists its clients before all French administrative jurisdictions under ordinary law (administrative tribunals, administrative appeal courts, *Conseil d'État*) or specialized jurisdictions such as the Higher Council of the Judiciary (*Conseil supérieur de la magistrature*), Court of Auditors (*Cour des comptes*), Court of Budgetary and Financial Discipline (*Cour de discipline budgétaire et financière*), disciplinary panels of the professional orders, etc.

### **Attorney before European Courts**

Cabinet Briard's practice also includes defending litigants before the European Court of Human Rights and the Court of Justice of the European Union.

### **Attorney before the Supreme Tribunal of Monaco and the Monaco Court of Revision**

Cabinet Briard has acquired strong expertise in litigations brought before the Monaco Supreme Courts. Its teams maintain close ties with attorneys in the Principality.
